

When do I need to reapply for an ESTA?

A new travel authorisation may be required in any of the following circumstances:

- The traveller is issued a new passport
- The traveller changes his or her name
- The traveller's country of citizenship changes; or
- The circumstances underlying the traveller's previous responses to any of the ESTA application questions requiring a "yes" or "no" response have changed.

Travel authorisation approvals will typically be granted for a period of two years or until the applicant's passport expires, whichever is sooner, ESTA will provide validity dates upon approval of the application. Therefore, a traveller must apply for a new travel authorization when a prior ESTA authorization or an applicant's passport expires. The associated fee will be charged for each new application submitted.

4. PCR tests and Covid Vaccination passes https://www.gov.uk/foreign-travel-advice/usa/entryrequirements

Children and young people

Children 17 and under are exempt from the vaccination requirement.

For travel, the US definition of a fully vaccinated child is the same as the definition of a fully vaccinated adult. This is different to the UK. Further details are on the US Embassy website. After arrival in the US, children 17 and under that are not fully vaccinated may be required to attest that they will take a test 3 to 5 days and will self-isolate should any symptoms develop or if they test positive. A parent or other authorized person should attest on behalf of a passenger 17 and under. More details are on the US Centers for Disease Control and Prevention (CDC).

If a child (17 and under) is travelling with only one parent or someone who isn't a parent or legal guardian, you may be asked to provide certain documents at the border. For further information, see the US Customs and Border Protection website.


