Dear Parent/Carer,

Your child will soon be partaking in a 'Spoken Language Endorsement' as part of their English Language GCSE. This means that pupils must undertake a prepared spoken presentation on a topic of their choice.

Key requirements:

- Presentations must be formal.
- Presentations must be between 5 and 10 minutes.
- Pupils must identify the subject for their presentations in advance and agree it with their teacher.
- Presentations must be planned and organised. Pupils should be advised that lack of preparation is likely to prevent access to the criteria for the higher grades.
- Pupils may use pre-prepared notes, PowerPoint etc. to assist them during their presentations however, this is not a requirement.
- As part of, or following, the presentation, pupils must listen to and respond appropriately to questions and feedback.

The selected date for this assessment in **Tuesday 11th June 2024**. The assessment will take all day as the pupils will need to perform their speeches and then become audience members for others' speeches.

Pupils are marked on a 'Pass', 'Merit', 'Distinction', basis and they will be told their result on the day. All pupils are filmed and a selection will be sent to the exam board for moderation so results may be subject to change.

Year 10 pupils are working on their speeches in lesson and through homework so it is vital that this is completed. We would encourage you to practise this with them, time them and support them in selecting an appropriate topic. A copy of the set homework and the mark scheme for the assessment is below for your information:

- Week 1 (WC 07/05/24) Decide on your S+L topic and complete relevant research
- Week 2 (WC 13/05/24) Write a first draft of your speech (approx. 4sides of A4)
- Week 3 (WC 20/05/24) Make edits to your speech. You must include persuasive devices and discourse markers. You must learn your speech over the holiday.

When talking this through with your child, the 'Distinction' criteria can be simplified to include:

- A clear argument or purpose e.g. To persuade me that social media has a negative effect on mental health.
- A confident delivery e.g. doesn't read from a sheet or board
- Thorough and well thought out points and responses to questions e.g. don't just answer 'yes' but expand on your reasoning.
