**Wolf Mountain**

At Wolf Mountain, pupils will rotate between different activities during the day and these include: climbing, caving, archery, and team challenges. If your child does not wish to take part in a particular activity then they are asked to let a member of staff know and we will be on hand to support.

**Uniform & Footwear**

Pupils should wear appropriate clothing and footwear as they will be completing physical activities. Any pupils not wearing appropriate clothing or footwear will be unable to complete the activities due to health and safety requirements. No clothing with offensive slogans or clothing that is revealing is permitted.

**Lunch**

Pupils are required to bring a packed lunch with them on the day. They are also required to bring a water bottle as some of the activities (such as caving) can get quite warm. If your child is entitled to Free School Meals then this will be provided for them.

Wolf Mountain do have bottled drinks, hot drinks and chocolate bars and crisps for sale if pupils wish to buy anything. Costs for these items vary between £1-£2 and cash would be needed if your child wanted to purchase any of these items.

**Medical Conditions**

If your child has an EpiPen, inhaler or any other medication that they are required to carry in the event of an emergency, please ensure that they have this with them in a clearly labelled package. Staff can look after this medication during the school day if necessary. If this medication is not supplied, it may prevent your child from completing the activities outside of school.
